1 SCOPE

1.1 SCOPE OF THE RELEASE

There are three changes in scope of the November 2021 REC Release. On 05 October 2021 the Change Panel approved Change Proposals R0001 and R0002 for implementation on 04 November 2021.

A decision on Change Proposal R0003 will be made by the Authority on 21 October 2021. Below will outline what is in scope of the Release, the detail will be communicated in the later sections of this document.

Should a decision not be made to approve R0003 by 21 October 2021, this will be added to the next standard REC release and a communication will be released on 22 October 2021 from the Code Manager including an updated Release Plan.
