## 1 SCOPE

## 1.1 SCOPE OF THE RELEASE

There are six Change Proposals (CPs) in scope of the November 2023 (3.6.0) REC Release. These are listed below, together with a summary of their impacts. Further information on each CP is available through the REC Portal. On 03 November 2023 these Code and technical changes will be delivered.

## R0017 – Invalid Requests for Site Technical Details

This CP seeks to provide clarity to Distribution Network Operators (DNOs) and Metering Equipment Managers (MEMs) on the process for requesting and sending Site Technical Details as part of meter asset installation, Switch or Change of Agent processes. This CP has been developed in conjunction with Balancing and Settlement Code (BSC), through the BSC Issue 99 Workgroup. <u>BSC CP1574</u> will make the associated updates to BSCP515.

#### R0110 – A Review of Supplier Access to Data on GES

The GES allows users to access gas market data, in accordance with the Data Access Matrix (DAM). Currently, Registered Shippers have a community view by default in the DAM, whereby they can see their designated Data Items for every Registerable Metering Point (RMP) in the market. Data Items exclusively available to Registered Shippers (and not Registered Gas Suppliers) include meter reading history and Meter Asset Manager history. This Change Proposal seeks to introduce Shipper-specific Data Items into the Registered Gas Supplier Portfolio view.
