1 SCOPE

1.1 SCOPE OF THE RELEASE

There are four Change Proposals (CPs) in scope of the March 2024 Extraordinary REC Release. These are listed below, together with a summary of their impacts. Further information on each CP is available through the REC Portal. On 28 March 2024 these Code changes will be delivered.

R0147 - Prepayment Levelisation

This Change Proposal seeks to introduce the necessary governance and charging arrangements into the Retail Energy Code, to reconcile the impact on Domestic Energy Suppliers of levelling the cost of standing charges to Domestic Consumers paying by means of a Prepayment Meter with those paying by Direct Debit.

R0093 - Uplift to CSS Maximum Demand Volumes during MHHS Migration Period

As part of the MHHS programme, it is necessary to migrate approximately 31 million MPANs from the existing settlement arrangements to those under the MHHS Target Operating Model. This will create a significantly increased volume of messages, whether for Switches or changes to Supplier Agents, for the Central Switching Service (CSS) Service during the MHHS Migration Period. The CSS Service Definition does not currently require the Switching Operator to be capable of processing these additional volumes.

This Change Proposal seeks to make the necessary updates to the REC, primarily to the CSS Service Definition, to ensure that the Switching Operator is appropriately prepared for the increase in message volumes that will be created during the MHHS programme migration period.

R0159 - House Keeping Amendment to the PARC

The Code Manager has identified two typographical errors in the approved legal text for the Performance Assurance Report Catalogue (PARC) as part of the implementation of R0147 Prepayment Levelisation and R0154 Performance Assurance Report Catalogue V5.1.

In the PARC drafting, R0147 has specified the Code Manager (RTS) as providing the new data submission report that is part of the R0147 solution. However, RTS will be acting for RECCo in provision of this report and not RTS as the Code Manager.

In the PARC drafting for R0154 we identified inconsistent capitalisation. As parts of the files used are validated, we think updating this typographical error will make it easier for REC Parties to submit files, or REC Parties and the REC Code Manager to identify how to resolve submission errors.
