Change of Tenancy Change Proposal (R0155) Working Group

R0155 has been raised by RECCo with the intention of reviewing the non-domestic Change of Tenancy process, including Change of Supplier with a Change of Tenancy. Market Half Hourly Settlement - Qualification Approach and Plan Consultation

On 31 January 2024, the MHHS QA&P, produced by the Retail Energy Code (REC) and Balancing and Settlement Code (BSC), was published for a 10-working day consultation. All REC Parties who are intending to operate in the new MHHS arrangements, will need to go through MHHS Qualification and are encouraged to provide feedback on this document.

The QA&P sets out the purpose of MHHS Qualification during the MHHS Programme, and provides the high-level plan and requirements, in relation to the BSC and REC.
