Pre-Qualification Submission

All Non-SIT Suppliers, Supplier Agents & Meter Equipment Managers (MEMs), and New Entrant Licensed Distribution System Operator (LDSO) Programme participants are required to provide a Pre-Qualification Submission for MHHS Qualification.

The submission will include all the information that Code Bodies need to make an informed judgement on a party's readiness and suitability to be allocated to a particular Qualification Wave. The information provided will also help Code Bodies to understand the resource and testing capacity required to support each Qualification Wave.

The Pre-Qualification Submission window opened on **5 February 2024** and final submissions must be provided **by 17:00 on 26 April 2024**. The Code Bodies are hosting a **Pre-Qualification Submission webinar on 7 March 2024**.

R0147 – Prepayment Levelisation Survey Reminder and Webinar

Change Proposal [R0147 - Prepayment Levelisation](#) was raised to progress the necessary changes to the REC, setting out how Payment Method Levelisation (PML) Reconciliation will operate and the obligations on RECCo and Domestic Suppliers. The Change Proposal is targeted for implementation on 28 March 2024 and the new PML Reconciliation Schedule will take effect on **01 April 2024**.

In readiness for R0147 being approved, and the Levelisation Policy being implemented, Supplier Contract Managers were emailed asking for a contact and bank details form to be sent to enquiries@recmanager.co.uk by **today, 09 February 2024**.

Category 3 Change Proposals

The Category 3 Change Proposals C3-0061, C3-0064 C3-0065, and C3-0066 have now been implemented.

C3- 0061 - As part of the administration of the Theft Detection Incentive Scheme, the Code Manager has reviewed the Theft Target Methodology based on the call for evidence and subsequent category 3 change proposal, with the following changes made:

- The Domestic customer segment pot has been split by Smart and Non-Smart Meter Type.
- Theft Targets have therefore also been split further by Meter Type for the domestic customer segment, with the target weighted towards Non-Smart metering.
- The Theft Detection Value has been adjusted using December 2023 Consumer Price Index (CPI) figure, with a further 20% escalator mechanism applied as outlined in RECCo's covering letter to the change proposal.
- The Attribution Methodology has been amended to include additional steps to obtain data from EES and GES for the purpose of assigning targets for Smart/Non-Smart splits.

A range of additional comments and feedback on the wider operation of the Theft Detection Incentive Scheme were provided by Parties through this process, and we thank Parties for taking the time to provide this input. This additional feedback is currently being reviewed by RECCo and the Code Manager in the context of considering wider potential changes to the Scheme and overall Theft Strategy

C3- 0064 - An update has been made to the [Energy Theft Reporting Scheme Reporting Timeframes](#) document to include details on the timing of key communications (including those that will require response/action by TDIS Qualifying Suppliers). There is no change to previously communicated timelines for theft data submission or scheme operation or any new requirements on TDIS Qualifying Suppliers – the update has been made to provide details of end-of-scheme activities and timings in one place to provide clarify and aid suppliers in forward planning.

C3-0065 - Retail Risk Register Updates - The thresholds ratified by REC Performance Assurance Board have been added to the Reporting Criteria within [Retail Risk Register v3.1](#). This impacts the following risk drivers:

- Risk Driver 8.9 The Supplier objects to a Switch with Change of Occupier.
- Risk Driver 8.10 A high-percentage of Objections use by a Supplier for Switch Requests relating to Domestic Consumers indicates potential inappropriate use.
- Risk Driver 8.11 A high-percentage of Objections use by a Supplier for Switch Requests relating to Non-Domestic Consumers indicates potential inappropriate use.

The update to thresholds will allow the Performance Assurance team to focus on outliers in the market in relation to Retail Risk 8.

C3-0066 - To reflect these implementations, the REC Baseline Statement has been updated to version 1.29.
