<u>Placing Reliance submission updates for Distribution Network Operators: Non-Functional and Operational, due 17 May 2024</u>

On 22 April 2024, the MHHS Programme published a Non-Functional and Operational update to the Qualification Approach & Plan Annex 1: Non-SIT LDSO MHHS Qualification Testing Approach and Plan.

In line with this and the Placing Reliance policy, confirmation is requested from Distribution Network Operators (DNOs) – known as LDSOs under the MHHS Programme – on whether they intend on Placing Reliance on Non-Functional and/or Operational Testing.

The deadline for this confirmation, as well as an updated Placing Reliance document, is **17 May 2024**. Early submissions are welcomed. Once we've received confirmation, the MHHS Programme's Qualification team and the Code Bodies will review your existing or updated Placing Reliance document with a Non-Functional and Operational lens.

You don't need to resubmit your Placing Reliance document if you don't wish to Place Reliance for Non-functional or Operational testing. If you have any questions, please email the Non-SIT LDSO Qualification team at LDSO_QT@mhhsprogramme.co.uk.

The Balancing & Settlement Code Company (BSCCo) is urgently looking for Workgroup members for the following BSC Modifications, which are being run together for efficiency:

- P471: Amendment to BSC Section E to allow more flexibility in procurement of BSC Agents
- P472: Amendment to provisions for Parties to bring claims against BSC Agents in BSC Section E

This will realise the benefits that support the operation of the new MHHS BSC central systems and avoid any impact on MHHS go-live.
