C3-0083 – SDEP User Guide Updates

[R0121 – SDEP Review Improvements – Process Types](#) has been approved for implementation on **23 August 2024** and introduces new Secure Data Exchange use cases (Process Types).

The Code Manager is updating the Secure Data Exchange Portal (SDEP) User Guide to align with the new Process Types and to review it more generally through [C3-0083 – SDEP User Guide Updates](#).

This Category 3 Change Proposal seeks to create a comprehensive overview describing the intended/best practice use of all SDEP Process Types to ensure that queries are raised correctly and therefore can be resolved more easily.

Industry feedback is sought on the draft updates to the SDEP User Guide through the [Consultations Register](#) on the REC Portal.

REC Code Roadmap Refresh – V1.1

A refreshed version of the REC Code Roadmap is now available. It presents the priority work items that the REC Code Manager is delivering now and in the near future that are resulting, or could result, in changes to the REC.

Points to note from V1.1 include:

- **New Change** Proposals and Change Issues raised – R0169, R0170, R0171, R0177, I0168, and I0172 to I0176 – in particular for themes Metering, Theft and CSS Processes.
- **Withdrawal** of a number of CPs including R0076, R0079, R0151, R0153 due to solutions being identified elsewhere, timing misalignment or scope change required.
- Number of **consulttions** (also including impact assessments, RFIs and surveys); 13 are active at the time of writing. Contact your OAM or change.management@recmanager.co.uk with any queries.
- Volume of change confirmed or proposed for the **June 2024 Release**; 10 CPs could be implemented in next month's release, spread across 7 roadmap themes. Refer to the [Portal](#) to find out more.
- **Future CPs** are likely on the Smart Meter installation survey (SMIS), Switching Incentives (CRS provider), MHHS REC legal text, MPAN/UPRN linking, multi-rate prepayment meters, prepayment unallocated process and Address Management. Look out for further information if you have an interest in these topics.

Please send us feedback on the roadmap, e.g. if your priorities are not sufficiently represented in the change pipeline, or if you would like to see other information included on the roadmap.
