#### R0098 - Optional Fuzzy Searching in EES

[R0098](#) was raised to allow optional fuzzy searching within the Electricity Enquiry Service (EES). This change was scheduled for release on **28 June 2024**. During performance testing of the changes applied to the EES API to accommodate the R0098 requirements, a degradation of response time was identified, and subsequently, the implementation of this Change will be delayed. **Smart Market Segment requirements exemption request for MHHS Qualification:** REC Performance Assurance Board (PAB) has approved the principles for exemptions from Smart Market Segment requirements for MHHS Qualification for Suppliers who meet the eligibility criteria and can demonstrate appropriate controls to operate without breaching their exemption conditions.

Please note that this provision is subject to approval by the BSC PAB and the implementation of the BSC Modification to allow application. The paper presented at PAB can be found [here](#). The REC Code Manager will work with BSCCo to provide further updates on this via the Qualification Working Group within MHHS governance.

**REC Assessment Criteria for MHHS Qualification:** REC PAB approved the REC Assessment Criteria V3.0 to include coverage of Operational requirements. The updated documents can be accessed via the REC Portal as a [PDF](#) or [Excel Spreadsheet](#).

**Assessing Party Readiness for MHHS Cutover reminder:** REC Party SIT participants should respond to the RFI on their plans for assessment to identify any risks to delivery by **08 July 2024**. The relevant Parties will have received this request via email.

## **REC Code Roadmap Refresh V1.3**

A refreshed version of the REC Code Roadmap (V1.3) has now been [published on the REC Digital Navigator](#). The Code Roadmap presents the priority work items that the Code Manager is delivering now and in the near future that could result in changes to the REC. Points of note from V1.3 include:
