MHHS Updates

C3-0089 - Meter Configuration Table (New)

This REC Category 3 Change Proposal has been raised to implement a new meter configuration table to support the MHHS Consequential Change – Standard Settlement Configuration Valid Set, which can be found here.

A consultation on this change is currently open and can be accessed via the Consultation section of this bulletin.

MHHS Data Cleanse: Test Population Activities

As per the **MHHS Data Cleanse Plan** the Distribution Network Operators (DNO), known as LDSOs in the programme, and MEMs are required to work together with other participants to complete certain cleanse activities. A test of this population processes is planned for July 2024, as agreed by the Migration & Cutover Advisory Group (MCAG).

- Population of ESME ID As per Section 4.1 of the cleanse plan, a bulk upload of ESME ID is
 required into each Registration Service in August 2024. For the test in July, the Data
 Communications Company (DCC) will extract the ESME ID and corresponding MPANs for each
 installed Smart Meter within the Smart Metering Inventory and provide a single encrypted file
 (.csv) to the Programme via SFTP.
- Population of Meter Location and Number of Displayed Register Digits As per Section
 4.2 of the cleanse plan, a bulk upload of Meter Location and bulk population of Number of
 Displayed Register Digits is required into each Registration Service in August 2024. For the
 tests of these population processes in July 2024, all MEMs have been primed to extract the
 Meter Location, LDSO MPID and corresponding MPAN for each installed Smart Meter within
 their portfolio, as well as to use current MTDs they hold for SMETS1 meters (Number of
 Register Digits data item), and to provide a single encrypted file (.csv) to the Programme via
 SFTP.

Once the extracts are received, the Programme will share (.csv) files with each DNO (by Market Participant Identifier (MPID)) via SFTP on **12 July 2024**. Each DNO will need to check they match their expectations. All DNOs are then required to provide a self-declaration for each to the Operational Readiness team at Operational-new-co.uk on **18 July 2024**.

Code Bodies have published an uplifted **version 1.2** of the **QAD** for consultation. Comments are due by **17:00** on **19 July 2024**. Version 1.2 of the QAD includes additional information on Non-Functional and Operational Qualification Testing. It also includes updates based on feedback from consultation on version 1.1. NEW! Programme Participant Information Request (PPIR) in relation to 'Validation of Service Provider Change of Supplier (CoS) Appointment' prior to formal Change Request

The Large Supplier Community have submitted a draft Change Request relating to the CoS and Change of Service Provider (CSP) processes.

As per the Programme's Change Control Process, a Change Request must include a single solution option and Implementation Plan before it is submitted to the Change Board. The Programme has issued a **PPIR** to understand more about the Implementation Plan, and to gauge more information that is critical to providing a complete CR to Change Board. Feedback on this PPIR is due by **17:00** on **22 July 2024**.
