August 2024 Extraordinary REC Release

The August 2024 Extraordinary REC Release will be implemented on **23 August 2024**. Further information on the Change Proposals that are being implemented as part of this Release are available on the Release Management page.

Please note that following further testing of R0098 - Optional Fuzzy Searching in EES and R0108 - Enabling Electricity Enquiry Searches Using A Unique Property Reference Number, both of which impact the Electricity Enquiry Service (EES) API, a decision has been made to exclude both of these changes from the August 2024 Release, to ensure ongoing performance stability of the EES API. Further work is taking place to determine whether these changes can be implemented without significant impact on the performance of the EES API, as well as considering when implementation may be possible. The updated August 2024 Release Plan (V1.1) has been published and reflects the changes that are currently in scope of the August 2024 Release.

As part of the August 2024 Release, the an updated version of the REC Baseline Statement will also be implemented to reflect the new version numbers of the updated products and the relevant changes relating to R0166 - Removal of the Green Deal Panel.

Request for Information on REC Services Accreditation Scheme documents related to R0137

As part of Change Proposal R0137 – Introducing Third Party Intermediary (energy broker) assurance and accreditation, RECCo are introducing a REC Services Accreditation Scheme under which TPIs can choose to be become accredited. The other route to accreditation is using an Industry-Recognised Accreditation Body.

There are multiple documents that RECCo must provide under this scheme (such as the REC Services Accreditation Scheme Guidance, REC Services Accreditation Scheme Form, TPI-Self Declaration of Compliance Form and TPI Self-Declaration of Fit and Proper Person Form) and whilst they are not code documents, and so not directly within the scope of R0137, RECCo is requesting feedback on what they have produced so far.

As such, the Code Manager has published a separate Request for Information where Parties can provide comments on the documents, should they wish to do so. These comments will be passed directly to RECCo and will not be published as part of the change. Comments must be submitted by **23:59** on **09 September 2024**.

R0155 - Change of Tenancy: Next Steps

Following the completion of the R0155 - Change of Tenancy: Evidentiary Standards and Timescales workgroup, and a legal review of the proposed solution, the Code Manager published an updated Change Report and Change Proposal Plan on 13 August 2024. The Proposal Plan, that includes a Party impact assessment, will be discussed at the REC Change Panel meeting on 20 August 2024.

If the Proposal Plan is approved by the Change Panel, we will issue the R0155 Change Report for Party impact assessment on **23 August 2024**, lasting 5 weeks before closing for responses on **27 September 2024**. The duration of the Party impact assessment would be extended by the Code Manager beyond usual industry standards. This would support industry capacity and allow respondents time to review the proposed solution that will be provided alongside the Party Impact Assessment and assess the impacts of the change on their organisation.

We will provide a further update following the REC Change Panel meeting, and will publish further guidance on the process, and how to respond, prior to the Party impact assessment being issued.
