MHHS Updates

MHHS Programme Systems Integration Testing (SIT)

The production Data Transfer Service (DTS) will be used for MHHS SIT Functional and MHHS SIT Migration Testing. The following preparatory activities will be carried out to support this:

- The REC Code Manager will update the Microsoft Access 'DTS Catalogue' to contain the new or updated Data Flow
 / Data Items. This updated Catalogue will be available to industry via the normal processes operated by the REC
 Code Manager when a change is made to that artefact.
- This updated DTS Catalogue will be made available on or before 22 December 2023.
- ElectraLink will update the production DTS with these changes before the SIT Functional test phase starts.

To prepare for using DTS, SIT participants should ensure that:

- You have configured your DTS gateways to support the new Market Roles and Market Participant IDs (MPIDs) that you intend to use in Testing.
- You can send and receive data flows that are consistent with the specification set out within the MHHS or Code Body design artefacts.

Programme Change Freeze

At the Programme Steering Group meeting on 06 December 2023 industry representatives formalised an MHHS Programme Change Freeze. The purpose of the Change Freeze is to address instability during Programme delivery, implementation and go-live that creates risk for the Programme, Code Bodies and Programme participants.

To create stability there is now an increased threshold for **all** change that impacts the MHHS Programme, with an expectation that changes will have implementation deferred until after go-live - MHHS Programme Milestone M10, 'Central Systems Ready for Migrating MPANs,' targeted for March 2025. In some cases, implementation may need to be deferred until after MHHS Migration has completed, unless they are required to fix a fault in the MHHS design. For clarity, changes with no impact on MHHS will not be impacted.

More information on the Change Freeze will be shared through the MHHS Programme Advisory Group meetings and the MHHS Programme will communicate with the Code Bodies on the Change Freeze approach accordingly for any impacted changes in progress.

The REC MHHS team will continue to engage with the Programme through the <u>Cross Code Advisory Group</u> and the Horizon Scanning process regarding how REC Change Proposals may impact MHHS. Guidance on how the REC Code Manager will manage Change Proposals during the change freeze will be shared in the new year.

MHHS Impacts to Data Transfer Network (DTN) Flows Consultation

The Design workstream has issued four Data Transfer Network (DTN) solution documents for consultation, relating to reports that will be sent from the Balancing & Settlement Code (BSC) Central Systems following a Demand Control Event (DCE). Comments are requested by 17:00 on 05 January 2024. Information for DNOs on Placing Reliance Submission and next steps for Non-SIT Suppliers and Agents

On 23 November 2023, the Code Bodies and Programme team held a Licensed Distribution System Operators (LDSO, or DNO under the REC) specific session to walk through and provide additional guidance on how to complete the Non-Systems Integration Testing (SIT) Placing Reliance Proposal Form. The session was recorded and <u>you can view the session here</u> along with <u>the supporting slides</u>. An updated version of the Non-SIT Placing Reliance Proposal Form and a worked example, as well as FAQs were published along with the December Qualification Working Group (QWG) papers which are published on the <u>Qualification and E2E Sandbox Working Group (QWG) page of the Collaboration Base</u>.

If you're a Non-SIT LDSO, the deadline to submit your Placing Reliance Proposal Form to the Programme via the Qualification mailbox at <u>LDSO_QT@mhhsprogramme.co.uk</u> is 05 January 2024.

The Pre-Qualification Submission template was also published along with the December QWG papers and are available on the QWG page of the Collaboration Base. The deadline for Non-SIT Suppliers and Agents to review and feedback on the Pre-Qualification Submission template is 02 January 2024. The Code Bodies and Programme team plan to hold a webinar in February 2024 to walk through and provide additional guidance on how to complete the Pre-Qualification Submission.

Each Financial Year, DCC as Switching Operator must have in place a plan (the Address Quality Plan (AQP)) setting out the actions proposed to be taken to improve address quality and meet the Address Quality Objective. For the AQP which is to be effective from 01 April 2024, DCC has brought forward the consultation to allow parties additional time to comment on the proposals. The consultation starts on 15 December 2023 and concludes on 31 January 2024. REC Parties are requested to review the draft Address Quality Plan and provide responses on the consultation response document.
