Any party that receives a message directly from Central Switching Service (CSS) and needs to validate its authenticity will need a copy of the latest CSS JWS (Public) Production signing certificate. Action is required by **20 February 2024**, **(2 Working Days)**. The JWS Certificate is issued to digitally sign each message and validates that the message sender is authenticated and the message integrity. Each CSS User that receives messages from CSS will need to install the updated certificate to ensure messages can still be authenticated. This <u>Portal page</u> provides further details.

R0093 Appeal

Party Assurance Un-acceded Metering Equipment Managers

We are aware that there are organisations who have an active Market Participant ID (MPID) in Market Domain Data (MDD), which gives them the ability to act as a MEM but are not yet acceded to the REC and have not qualified. We previously attempted to engage with these MEM Parties in October 2023, however, we did not receive responses. We are now seeking to remove these MEMs from MDD (i.e. end-dating the relevant MPIDs within MDD). We want to ensure this is actioned in a controlled manner, if an un-acceded/unqualified Party does engage we are keen to provide them with a path to qualification and compliance.

From our analysis of the data held within the Electricity Enquiry Service (EES), we are reaching out to Electricity Suppliers who have appointments associated with these un-acceded MEMs, suggesting that action is taken.

As presented at the February Retail Issues Group meeting, if an organisation wishes to act as a MEM they should accede to the Code and become a Qualified party in accordance with the provisions of the Qualification and Maintenance Schedule (REC Schedule 15 Section 1, Clause 1.1). Furthermore, REC Schedule 14, Clause 2.3 requires Suppliers to ensure appointed MEMs are qualified in accordance with the provisions of the Code.

We ask Parties who have been contacted to complete the required action by **20 February 2024** and/or inform us if they are unable to complete the required action in time, alongside their expected timelines for appointing appropriate MEMs for the MPANs noted. Should the MEM organisation contact the Code Manager, complete REC accession, and commence the transition requirements between now and the last date for requesting changes for March MDD release (i.e. before 20 February 2024), we will allow them to continue to remain in MDD provided they continue to remain engaged and complete their transition requirements.

MHHS Supply, Distribution & Transmission Licence Review Consultation

The MHHS Programme has published the **MHHS Supply, Distribution & Transmission Licence Review** document for consultation. Comments are due by **17:00** on0 **13 March 2024**.

There is a BSC requirement (<u>BSC Section C 12.5.2(a)</u>) for the MHHS Senior Responsible Owner (SRO) to "identify and inform the Authority of, any and all further modifications to energy licences which are required for MHHS implementation". The Programme has reviewed all Standard Licence Conditions in the Supply, Distribution and Transmission Licences, which are available on the Licences and Licence Conditions page on the Ofgem website.

As a result, we conclude that **no licence changes are required for MHHS implementation**. However, the review identified a few areas that Ofgem may want to consider as to whether changes are required as a consequence of MHHS (e.g. reference to Profile Classes). Participants are requested to review the document and provide comments (if needed).

MHHS Pre-Qualification Submission

All Non-SIT Suppliers, Supplier Agents and MEMs, and new entrant DNOs - referred to as a Licensed Distribution System Operator (LDSO) in the MHHS Programme - are required to provide a Pre-Qualification Submission (PQS) for MHHS Qualification.

The submission will include all the information that Code Bodies need to make an informed judgement on a Party's readiness and suitability to be allocated to a particular Qualification Wave. The information provided will also help Code Bodies to understand the resource and testing capacity required to support each Qualification Wave. For further information on the Qualification Waves, Parties should consult the <u>Qualification Approach and Plan.</u>

Please note that:

- SIT participants are not expected to submit the PQS for the roles and Market Participant IDs (MPIDs) they are participating with in SIT. The proposed process for Qualification Assessment Document (QAD) submission for SIT Participants is set out in the Qualification Approach and Plan.
- Existing DNOs participating in Non-SIT LDSO Qualification are not expected to submit the PQS.

All electricity REC Parties are required to become MHHS Qualified to operate the new MHHS arrangements. Some REC Parties have volunteered to support MHHS Programme testing through SIT. Others (referred to as Non-SIT Parties) will need to undertake Qualification Testing directly with Code Bodies.

The PQS window opened on **05 February 2024** and final submissions must be provided **by 17:00 on 26 April 2024**. The Code Bodies are hosting a **Pre-Qualification Submission webinar on 07 March 2024**.
