	RECCo's Code Manager Evolution Stakeholder Advisory Group
	As set out in RECCo's <u>Draft Strategy and Forward Work Plan 2024-27</u> , two years into live operations, RECCo conducted a thorough assessment of the performance and effectiveness of the Code Manager services. This was to ensure alignment with industry needs and inform its future re-procurement strategy, particularly as the contract terms are set to end in September 2024. While RECCo has initiated a continuous improvement programme across the Code Manager service over 2024/25, it is also considering the evolution of the service in the medium to long term based on stakeholder feedback.
	To support the Code Manager evolution project, RECCo is establishing a Stakeholder Advisory Group, a small group of industry stakeholders who provide informal advice to the project team. Its primary function will be to offer guidance, perspectives and insights throughout various stages of the project lifecycle, running from March 2024 until at least the completion of any required procurement activity, at which point its future will be reviewed and determined.

Representation from REC Parties and users of the Code Manager Service is crucial, and RECCo is seeking diverse perspectives to ensure comprehensive coverage.
