Licensed Distribution System Operator (LDSO) Secure File Transfer Protocol (SFTP) Access Request Form

The MHHS Programme has issued a PPIR to DNOs – referred to as LDSOs in the MHHS Programme, relating to the SFTP environment. The SFTP is a key dependency for LDSO testing and the migration of production data between the Data Communications Company (DCC) systems and each LDSOs Metering Point Registration System (MPRS). All LDSOs are obligated to complete this activity before the initial migration of production data in Summer 2024.

To further support participants in understanding the SFTP, the Programme has produced an SFTP Guide which provides a summary of the SFTP and a technical description of the environment which can be found on the <u>Data page of the MHHS</u> website. LDSOs are requested to complete this PPIR form by 17:00 on **19 March 2024**.

<u>Licensed Distribution System Operator (LDSO) Import/Export Meter Point Administration Number (MPAN) matching</u> deadline

The MHHS Data Cleanse Plan sets out a target for LDSOs to have associated a minimum of 80% of Export Meter Point Administration Numbers (MPANs) to the relevant Import MPAN by **22 March 2024**. As such, the Programme requests that all LDSOs issue a self-declaration to the Programme by **22 March 2024** (the matching deadline).

For more information on what details you need to include in your self-declaration and valid exceptions, please see slide 11 of the <u>Data Cleanse Working Group (DCWG) meeting papers</u> from **29 February 2024**. RECCo's Code Manager Evolution Stakeholder Advisory Group

As set out in RECCo's <u>Draft Strategy and Forward Work Plan 2024-27</u>, two years into live operations, RECCo conducted a thorough assessment of the performance and effectiveness of the Code Manager services. This was to ensure alignment with industry needs and inform its future re-procurement strategy, particularly as the contract terms are set to end in September 2024. While RECCo has initiated a continuous improvement programme across the Code Manager service over 2024/25, it is also considering the evolution of the service in the medium to long term based on stakeholder feedback.

To support the Code Manager evolution project, RECCo is establishing a Stakeholder Advisory Group, a small group of industry stakeholders who provide informal advice to the project team. Its primary function will be to offer guidance, perspectives and insights throughout various stages of the project lifecycle, running from March 2024 until at least the completion of any required procurement activity, at which point its future will be reviewed and determined.

RECCo is inviting nominations from industry stakeholders for positions on the Stakeholder Advisory Group. Representation from REC Parties and users of the Code Manager Service is crucial, and RECCo is seeking diverse perspectives to ensure comprehensive coverage. Nominations are specifically requested from:

- Suppliers at least 3 representatives (to ensure representation from gas and electricity, non-domestic and Domestic, larger, and smaller Suppliers)
- Network Parties at least 2 representatives (1 Distribution Network Operator and 1 Gas Transporter)
- Metering Equipment Managers at least 1 representative

The group is proposed to meet monthly for virtual meetings lasting 2-3 hours. Where necessary, extended meetings or extraordinary meetings may also be scheduled. RECCo is seeking individuals who meet the following criteria:

- Knowledge of REC governance and processes
- Direct experience of interacting with the Code Manager service
- Ability to act independently from the commercial interests of their respective organisations, especially when such interests might conflict with the demands and requirements of the market
- Willingness to treat all information confidentially and sign a confidentiality agreement
- Wholly independent of, with no conflict of interest with, current Service Providers and/or potential bidders for future procurements
