The Performance Assurance Dashboard has been updated on 18 June 2024 with the following changes.

The Risk Driver Summary and Risk Driver - MPxN Level tabs within the Performance Assurance Dashboard will be updated to improve its layout, simplify the design, and provide more clarity on Risk Driver descriptions. The filter pane for the Risk Driver Summary tab will also include additional information on Risk Drivers.

The Meter Specific Topic Monitoring tab within the Performance Assurance Dashboard has been removed as part of wider changes to how we monitor metering performance. We have used the information that has been provided to us to build an evidence base over the quality of metering data. We will continue working to address issues identified in this area and don't need to continue to collect this data to proceed. We would like to thank all that have provided this information.

Theft Detection Incentive Scheme 2024/25

We would like to remind Suppliers that all data submissions for Theft Scheme Year 2024-2025 are required to be made using the 1341 file specification to capture thefts for incentive pots Smart and Non-Smart Meter Type for the Domestic customer segment. This consultation mainly focuses on monitoring and controlling Migration Execution, having focused on developing, initialising and maintaining the Migration Schedule in the first Migration Framework consultation. It also includes
