1 SCOPE

1.1 SCOPE OF THE RELEASE

There are currently two changes in scope of the February 2023 (3.3.0) REC Release. On 30 November 2022 the Technical Expert Panel approved Change Proposals R0052 and R0055 for implementation on 24 February 2023.

On the 22 February 2023 the Technical Expert Panel will make a decision on R0074. Below will outline what is in scope of this release, the detail will be communicated in the later sections of this document.

Should a decision be made to not approve R0074 by 22 February 2023, this change will be added to the next standard REC release and a communication will be released on 22 February 2023 from the Code Manager including an updated Release Plan.

R0052

This change will amend the frequency of the Gas Enquiry Service reports to the frequency that was agreed at the implementation of REC V3.0 and is utilised in operation. This change will amend:

- Gas Enquiry Service Definition
- REC Charging Statement

R0055

This change will align the timeframes within the REC Products that refer to the notice period for CSS schedule maintenance and system outages. This change will amend:

· Switching Operator Service Definition;



R0074

Should this change be approved, this release will implement a community view of Data Items for Meter Equipment Managers in the Gas Enquiry Service. This will be a Code and Technical change. Due to the close proximity of approval to the implementation date, this change will be delivered via a phased approach. The Code element will be delivered via a big bang on 24 February 2023 with the Technical element being delivered at a later date. This change will amend:
